Based on Articles 25 and 27 of the Law on Higher Education (*Official Gazette of the Sarajevo Canton*, no. 42/13 – consolidated version) and Article 15 of the Rules on Accreditation of Higher Education Institutions and Study Programs (*Official Gazette of the Sarajevo Canton*, no. 26/13), Minister of Education, Science and Youth of the Sarajevo Canton hereby issues the following

**DECISION**  
**ON INSTITUTIONAL ACCREDITATION OF INTERNATIONAL BURCH**  
**UNIVERSITY**

**I**

Higher Education Institution – International Burch University is hereby awarded the institutional accreditation.

**II**

The Decision on Accreditation is issued for the time period of five years.

**III**

International Burch University shall file a reaccreditation application not later than six months prior to expiration of the deadline referred to in Ad. II hereof.

**IV**

The deadline referred to in Ad. II hereof shall start to run as of the day the Decision becomes final.

**Reasons**

Higher Education Institution International Burch University filed with the Ministry of Education, Science and Youth of the Sarajevo Canton an application for the institutional accreditation. The Ministry of Education, Science and Youth of the Sarajevo Canton received the application under Ref. No. 01-32/14 dated 13 January 2014.

With a letter no. 11-05-38-32838-1/14 dated 24 April 2014 the Ministry of Education, Science and Youth of the Sarajevo Canton referred the received application to the Agency for Development of Higher Education and Quality Assurance of BiH recommending the appointment a board of experts. Based on that the Agency issued the Decision on Appointment of the Board of Experts no. 05-33-369-2/14 dated 13 May 2014.

Based on the Report and Opinion of the Board of Experts stating that Higher Education Institution International Burch University meets all the requirements set for

the accreditation, the Agency for Development of Higher Education and Quality Assurance of BiH issued the Accreditation Recommendation no. 05-33-1-369-5/14 dated 6 August 2014 and referred it for further action to the Ministry of Education, Science and Youth of the Sarajevo Canton.

Having analyzed the Report and the Opinion of the Board of Experts, as well as the Recommendation of the Agency for Development of Higher Education and Quality Assurance of BiH, the Ministry of Education, Science and Youth of the Sarajevo Canton acknowledged that all requirements set for issuing an institutional accreditation to the applicant have been met, and ruled as in the operative part hereof.

One copy of this decision is served with International Burch University and Agency for Development of Higher Education and Quality Assurance of BiH each for the purpose of any actions or measures set forth by the Framework Law on Higher Education in BiH and the Law on Higher Education of the Sarajevo Canton.

**Note on Legal Remedy:** An appeal lies from this Decision within 15 days as of the date of its service. The appeal is to be filed to the Agency for Development of Higher Education and Quality Assurance of Bosnia and Herzegovina via the Ministry of Education, Science and Youth of the Sarajevo Canton.
